



VOTING MEMBERSHIPS

INDIVIDUAL GOLF

An Individual membership shall consist of one-member aged 40 and above prior to June 30th of the current year that are signing up to play golf and have full dining privileges. An Individual membership is entitled to one (1) vote.

FAMILY GOLF

A Family membership shall consist of a married couple or significant other, age 40 and above prior to June 30th of the current year, together with any of their children who are unmarried and have not reached the age of eighteen (18) years old by June 30th of the current year. ALL must reside in the same dwelling. In addition, full-time students that are not self-supporting will also be considered as being included in a family membership. A family membership is entitled to one (1) vote.

The Primary or voting member must be identified and is entitled to all privileges. The spouse and qualified dependents are subject to restricted tee times.

Please refer to the Club's Rules and Regulations for appropriate tee times.

Spouses are eligible for Club tournaments and recognized leagues. Children ages thirteen (13) - seventeen (17) are restricted to special hours. Children under thirteen (13) may play at certain times per the Golf Professional's discretion.

A Significant Other is defined as living in the same household (driver's license address must match)

INTERMEDIATE

An Intermediate Membership shall consist of Families / Individuals who are between the ages of thirty-five (35) and thirty-nine (39) prior to June 30th of the current year. Playing times and privileges are the same as the classification listed above.





YOUNG PROFESSIONAL 2.0

For golfers 30-34 prior to June 30th of the current year, this membership has all the same privileges as our Family Membership.

YOUNG PROFESSIONAL

For golfers ages 21-29 prior to June 30th of the current year, this membership has all the same privileges as a Family Membership.

RETIRED COUPLE

Membership shall consist of a husband and wife or significant other residing in the same dwelling. To qualify, a member must be 62 years of age prior to June 30th of the current year and retired. A Retired Membership may also be granted to those over the age of 70 that are not fully retired from employment. Membership is entitled to one (1) vote. The primary or voting member must be identified and is entitled to all privileges.

Significant Other is defined as living in the same household (driver's license address must match)

RETIRED SINGLE

Membership shall consist of one member. To qualify, a member must be 62 years of age prior to June 30th of the current year and retired. A Retired Membership may also be granted to those over the age of 70 that are not fully retired from employment.





NON - VOTING GOLF

NON - RESIDENT

A Non-Resident Membership shall apply to any family / individual who has a permanent residence (designated as a minimum of 9 months of the year) that is located outside of Erie County and 40 miles or more away. Non-resident is considered a “restricted” membership. Non-Residents are permitted to play anytime during the week, but after 10:30AM on weekends and holidays. Non-Residents are eligible for all tournaments except the club championship.

SOCIAL

A Social Membership shall be an individual twenty-one years of age or older who shall be permitted the use of the club facilities as from time to time may be prescribed by the Board of Directors or by the By-Laws.

Golf Privileges: A social member is permitted to play anytime prior to Memorial Day Weekend and after Labor Day Weekend. During the summer months, a social member is limited to four rounds of golf. Social members may participate in scheduled events and tournaments when available. (Golf members have first priority.) Participants must have an established GHIN handicap. Tournament play counts toward the four times.

Note: The Three-day member guest counts as only one round.

The designated green fee always applies. Golf members may also participate in the club’s designated leagues. An annual fee is required as established by the Board of Directors. League play does not count toward the four rounds.





SOCIAL - CORPORATE

A Corporate Social Member shall be a member twenty-one years of age or older, who shall be permitted the use of club facilities as from time to time may be prescribed by the Board of Directors or by the By-Laws. Each Corporate Social Membership is entitled to have up to five (5) Associate Social Memberships. (Note: a golf member may serve as a corporate social member at no extra charge.) Golf privileges are the same as a social member.

SOCIAL - CORPORATE ASSOCIATE

An Associate Corporate Social Member shall be a member twenty-one year of age or older and who is an employee of a Corporate Social Member. They shall be permitted the use of the club facilities as from time to time may be prescribed by the Board of Directors or by the By-Laws. Social golf rules apply.

Note: Mercyhurst University faculty and North East school district employees also qualify for this category.

JUNIOR

A Junior Membership shall consist of an individual from twelve (12) years of age up to twenty (20) years of age prior to June 30th of the year of application. There are restrictions as to playing times as per the Club's Rules and Regulations.

COLLEGE

A College Membership shall consist of full-time college students (12 credit minimum) age 21 and over. There are restrictions as to playing times as per the Club's Rules and Regulations.

Note: Juniors and College members do not have a F&B minimum. Juniors are allowed to charge to their account with a parent/guardian's signature verifying all charges will be paid in full on a monthly basis.



OTHER TYPES OF MEMBERSHIP

AFFILIATE

Out of town members from another recognized golf club may use Lake View Country Club for dues of \$800 per month. Cart Fees apply. This membership only permits play in the 3-day Member-Guest tournament with a primary member and other Stag events as a guest.

CLERGY

Members of the clergy have a special rate.

DINING ONLY

Open to any person wishing to have a food and beverage membership to our club. Member will receive a member number, but will be restricted from charging to this number and must pay at each dining occurrence with credit card or cash.

Social events will have *last call* if reservation openings are still available.

Unless otherwise agreed upon by the Board of Directors, this membership does not include the option to use club for personal events.

No minimum required and no golf privileges allowed.
